# PRESTON RICHARD PARISH COUNCIL

MINUTES OF THE VIRTUAL MEETING OF PRESTON RICHARD PARISH COUNCIL HELD ON MONDAY 20<sup>th</sup> April 2020.

- **1.20 APOLOGIES:** Cllrs J Hayhurst, Mrs M Daunt, Cllr County/District R Bingham
- 2.20 REQUESTS FOR DISPENSATION None
- 3.20 **DECLARATIONS OF INTEREST –** Cllr Inman planning application SL/2020/0148
- **4.20 MINUTES** The minutes of last month's meeting were sent to councillors and were confirmed as a true and accurate record.
- 5.20 B4NPR BROADBAND UPDATE Mr Lyons advised the meeting that since the last presentation to the Parish Council the Preston Richard project had been adversely affected by
  - a) the Corona Virus pandemic which meant that all group "digging days " had been cancelled and house installations were also suspended
  - b) the continued uncertainty of the timing of the Story Homes development meant that B4RNPR had to devise other methods to achieve their goals However he was pleased to report that the project had gone live in properties at Crooklands and Millbrook where B4RN had been able to access properties before the lockdown regulations had come into effect. He also thanked all members of the public who had helped with the digging and providing the brownies and bacon butties to support the diggers, a real community spirit. Additionally he advised that the main cabinet had been installed at the Village Hall. The Steering Group continue to meet weekly using video conferencing
- 6.20 **COVID-19 –** The Chair introduced Roger Gorman, the leader of the Preston Richard Emergency Plan and thanked him for all his hard work in putting the Plan together and then implementing the actions to support the vulnerable in our Parish. Roger advised that on March 13th when he became aware of the emergency had cards printed to distribute to the parish offering help to anyone who needed it. He held a meeting in the Village Hall and got more than enough volunteers to help the vulnerable which showed a great community spirit, the Parish Clerk got a list of all vulnerable patients from doctors surgeries and these were crossed checked with the information the team had put together to make sure no one slipped through the net. To date we still have 30 volunteers helping others and 10 on the reserve list should any be taken ill. He is pleased to say so far none of the volunteers in Preston Richard have fallen ill. We have had one person registered as having the virus and no deaths. The Bakery, the Village shop and the Chippy Van have been fantastic they have all pulled together and people have been out clapping on Thursdays to support our health workers. Roger wished to thank Martin the Chair of the Parish Council and the Clerk for all their support without which he could not have done it. The Council

- reiterated their thanks and support for all the Emergency Plan Team and all the volunteers and businesses that have pulled together at this very difficult time.
- **7.20 POLICE REPORT** The Police are not currently preparing reports due to the current crisis. They will however advise parishes of important information should it be necessary
- **8.20 OPEN SESSION -** No matters were raised on this item
- 9.20 CIL MONEY PROJECTS The Clerk reported no applications had been received and no CIL had been forthcoming and she expected that there would be a delay due to staff working from home and busy with other matters.
- **DISTRICT/COUNTY COUNCIL MATTERS Clirs Cooper and Harvey although** 10.20 invited to attend have not responded. Cllr Bingham sent a report covering both District and County matters as Follows. Due to the current situation there is little council news, the District Council and Police & Crime Commissioner elections have been postponed; there have been no council meeting since 15<sup>th</sup> March. The District Councillor seat held by Cllr Cooper will be contested next year at the same time as the County Council Elections. For the first three weeks of the crisis Cumbria was in the top six of affected authorities. On one day 70 reported cases in Cumbria compared with 37 in Manchester. Cumbria's Chief responsible officer attributed this disparity between our least populated area and one of the most congested cities by suggesting that many affluent people living in Cumbria were returning from skiing trips, but this would apply to Cheshire and parts of London. More certainly the huge influx of visitors to the area boosted the figures. Following the lockdown most officers are working from home, on the 9th April 90% of County and District staff reported they are well and working. Green bin collection has been suspended in favour of domestic and recycling services. The Counties Children's Services have complex concerns, with schools closed referrals of vulnerable children are down by 40%, but calls regarding domestic violence have increased. Meals are available for those who usually get free meals and for family key workers at some schools, this has had a mixed take up and the alternative payment of £15 per week has alleged problems of fraud and availability of suitable meals.

- **12.20 PLAYING FIELD/VILLAGE HALL -** The Chair advised the play area is alright at the moment and he praised the public for staying away at the present time.
- 13.20 CALC NEWSLETTER The newsletter was mainly concerned with the audit changes and this has been dealt with by the Clerk and will be dealt with under the finance item.
