- **185.19 DECLARATIONS OF INTEREST –** Cllr Inman on planning application SL/2020/0148
- **186.19 MINUTES –** The minutes of last month's meeting were sent to councillors and were confirmed as a true and accurate record.
- 187.19 B4NPR BROADBAND UPDATE Mr Lyons submitted the following report. B4RNPR Grant Request for Financial Year 2020/2021
 It is expected that the Broadband Project for Preston Richard will not be completed before the end of Financial Year 2021/22. Whilst the bulk of the work involved will be carried out by unpaid volunteer helpers from the Community inevitably certain expenses will be incurred, at this stage it is difficult to identify precisely what those expenses will be as the Project is developing but it is expected they would fall in 4 broad headings
 - ➤ Health and Safety expenditure to protect volunteers (PPE, First Aid training etc.)
 - ➤ Equipment whilst volunteers provide their own basic tools it is unreasonable to expect them to stand the cost of heavy deterioration of personal high value items e.g. Drills
 - Materials
 - ➤ Contractor costs when volunteer labour is not appropriate
 Therefore B4RNPR requests the Parish Council to consider in the next financial year a general grant from Parish funds of £600 and a grant from any money received from the Community Infrastructure Levy (CIL) of £1000.

The general grant of £600 was agreed under majority email acceptance however the Parish Council does not know what CIL money if any will be available until April so that grant will be discussed at that time.

188.19 POLICE REPORT – Monthly Area Update February 2020

Area update covering Kirkby Lonsdale, Burton, Holme, Preston Patrick, Preston Richard, Lupton, Casterton, Sedgwick, Stainton, Old Hutton, New Hutton and Natland.

The early part of February was taken up by several days of Street safe surveys in Kendal, getting opinions as to what they feel are the local issues most

affecting them. This was a multi-agency effort and many residents have filled out the survey forms, the results will be collated and discussed by all agencies involved to identify improvements or solutions to issues raised.

Also there seems to be a rise in the amount of telephone scams being brought to our attention, please do not divulge and personal details to any incoming phone calls, scammers have ways of displaying telephone numbers that are not the lines they are calling from if in doubt hang up and seek advice.

192.19 COUNTY/DISTRICT COUNCIL MATTERS -

R. Bingham CCC Feb/Mar work has been dominated by floods and finance, although as far as I am aware no one has been flooded although I have asked the drains to be looked at in Main Street Endmoor. I have also reported the large pothole at Milton Moor. There is another proposal to stop any parking on pavements. After discussions with CCC development Control they were persuaded to amend the WWtW site to get more tree screening. SLDC advises Council Tax is increasing by 2%and the police rate by 8% to pay for extra officers, County's Council Tax for both the general rate and Adult Social

Services are up by 1.9%. There have been extra Government grants of £600,000 for Special Educational Needs and £1.6m for cycleways and buses. I supported a grant for the needs of Sensory Disabled People but regrettably this was defeated.
