MINUTES OF THE MEETING OF PRESTON RICHARD PARISH COUNCIL HELD IN ENDMOOR VILLAGE HALL ON MONDAY 17th June 2024

- 31.24 DECLARATIONS OF INTEREST None
- **32.24 MINUTES –** The minutes of the last meeting were confirmed as a true and accurate record
- 33.24 CO-OPTION OF NEW COUNCILLORS After initial interviews had been carried out previously 3 candidates were invited to attend for co-option. The members of the full council present were given the opportunity to ask questions, a show of hands on all 3 candidates were unanimous on accepting the 3. Cllrs. Inman, Parr and Toone were duly co-opted.
- **34.24 ELECTION OF VICE CHAIRMAN-** Cllr Inman having previously been the Vice Chair of the Parish Council agreed to resume the role.

35.24 OPEN SESSION -

The Clerk informed the meeting the footpath from the A65 to Gatebeck Road which has been left in a very poor state since it was moved by Story Homes, has been reported and Westmorland & Furness (W&F) Council will be dealing with it at the end of June. New finger posts have been ordered and will be installed in the autumn.

A further problem reported to the Clerk was the matter of a branch on one of the trees on the playing field, this has been confirmed as safe however as it is growing at an odd angle, permission has been sought to remove the branch from the planning department. Cllr Inman asked if we could report the trees alongside Crooklands bridge on the B6385 and ask they be cut back as it was causing difficulties in seeing the traffic movement on the single-track bridge. The Clerk will report.

36.24 UNITARY COUNCIL MATTERS -

Cllr Battye advised she is aware the traffic figures from recent monitoring in Endmoor are now in and she is to organise a meeting between Highways and the Parish Council to discuss them and try to find a solution to the speeding problem. She also advised W&F are still looking into how to charge for future street lighting charges.

She told the meeting that the proposed plans for the Hillside change of use as shown in the planning section 2024/0525/FPA are to go to committee on 27th June as the Officers are minded to accept them and therefore the Committee are wanting to hear from members of the public who have applied to speak before the committee make their decision. The committee will be making a site visit. She also stated a new Locality Board Officer had been appointed. Cllr Battye wished to remind the Councillors of the consultation on the new Local Plan that will merge all previous held plans for areas which are now under W&F control. The clerk advised the police had arrested someone for misuse of drugs in Longpool Kendal but otherwise they had been busy with the Appleby Horse Fair organising routes and managing matters arising.

38.24 PLAYING FIELD/VILLAGE HALL -

The matter of the recent damage done to the children's play park was discussed, the Clerk advised this had been reported to the police and footage was available for the police to further the matter. One of the culprits has been identified and the police will follow up. The Parish Council felt it was important we follow through with this process particularly as the equipment was left in a dangerous state. The drainage on the playing field is to be delayed due the contractor not having the time at the moment but they can carry out the work next year and have agreed to hold the price. The Council felt this was acceptable and agreed the work to be done April/May 2025. The Chairman asked the Clerk to report the bins on the play area which had not been checked or emptied for the last 2 weeks.

39.24 HIGHWAYS -SPEEDWATCH – A report from Cllr Parr was given to the council as follows:

We re-established the speed watch team in April, and received training from the police. We now have a team of 6 people, as we were given the strong guidance from the police to only do a Speedwatch session in pairs, therefore we would benefit from having more people in the team. Speedwatch sessions are infrequent and irregular, which helps avoid traffic learning when to expect us, though ideally, we would like us to be doing at least one session per week dependent on people's availability.

In late April into May we had 3 sessions of Speedwatch. From those sessions we monitored traffic from the bench on the A65. Across the sessions the average speed of traffic exceeding the speed at which the police would be interested at was 38.6 mph. This **does not** include all the people not speeding. The maximum speed recorded was 47 mph in each session, well above the 30mph speed limit through the village.
