- **45.24 MINUTES –** The minutes of the last meeting were confirmed as a true and accurate record

46.24 OPEN SESSION -

As there were a large number of members of the public present wishing to discuss the Hillside planning application 2024/0525/FPA and 2024/1161/LDPR the Chair brought planning matters forward. Although the planning application for 'change of use' was refused the applicant has applied for a Lawful Development Certificate to use the building as a children's care home. Peter Winter on behalf of the group explained the decision-making behind the application which is based on legalities, no statutory requirement to consult third parties including parish councils or neighbours. They may consult with planning authorities for relevant information, all other information is deemed irrelevant Cllr Atkinson proposed a vote on the use of Hillside as a children's care home and Cllr Inman seconded the council unanimously voted against such use. The clerk will discuss what if anything can be done with planning but in the end, it will be up to the Westmorland and Furness Solicitors to make the final decision. The Chair felt it would be useful to have some idea of the concerns and suggested the public make enquiries on this. Cllr Toone suggested there should be a timescale attached to this activity. Several questions were asked on rights of appeal etc. which Peter Winter answered but it was felt we would have to wait and see the outcome first.

The Clerk informed the meeting the footpath from the A65 to Gatebeck Road has now been tidied up and will be maintained by Westmorland & Furness Footpath department.

A problem was reported to the Clerk regarding a sewer chamber which is causing a stench. This chamber became a problem when Story Homes linked into the sewer system on Sycamore Close. The Clerk has been in touch with Story Homes and they are trying to sort it out.

47.24 UNITARY COUNCIL MATTERS -

- The Local Plan consultations are underway, it is currently assessing areas available for development and therefore, she urged all councillors to check on it when produced to ensure it was correct, the Clerk advised all info received had been passed on to Councillors. - Cllr Battye advised she has not received the traffic figures for Endmoor yet but will chase them up. A meeting is to be arranged between Highways and the Parish Council in August to discuss them and try to find a solution to the speeding problem.
- She also advised W&F are still looking into how to charge for future street lighting charges.

49.24 PLAYING FIELD/VILLAGE HALL -

- Planning permission has been granted to proceed with work on the trees and the work is being carried out.

- The play area equipment has been repaired, the climbing frame rope has been reinstated, the train has a new roof and the basketball court has a protective fence from the car park.

50.24 HIGHWAYS - SPEEDWATCH -

Cllr Parr gave a report on the findings of the Speedwatch group and it would appear that there is a considerable amount of speeding going on, as we suspected. Of all those caught speeding (108) the average speed of all the speeders was 39mph. These figures together with registration numbers are sent to the police for follow ups. The Council thanked Cllr Parr for his work in managing the group and the stats. The Speedwatch gun is due for calibration and the Clerk asked if this was to be done, Cllr Inman proposed we do, Cllr Atkinson seconded and all agreed. The Clerk will organise the calibration.
